

Part B

Requirements

The requirements for the DOE Declassification Plan are determined by Executive order and public law.

1. Executive Order (E.O.)12958, *Classified National Security Information*

Automatic Declassification of 25-Year-Old Permanent Record Documents

E. O. 12958, Section 3.3, *Automatic Declassification*, requires that all classified records that (1) are more than 25 years old and (2) have been determined to have permanent historical value under title 44, United States Code, shall be automatically declassified whether or not the records have been reviewed. Subsequently, all classified records shall be automatically declassified on December 31, of the year that is 25 years from the date of their original classification, except as provided in section 3.3 of the Executive order. An agency head may exempt from automatic declassification specific information listed in section 3.3 of the Executive order. The information to be exempted is documented in a classification guide approved by the Interagency Security Classification Appeals Panel (ISCAP). Documents that may contain information exempted from automatic declassification are to be reviewed by the agency to determine if the documents are to be exempted from automatic declassification. December 31, 2006, is the due date for records 25 years or older on that date.

Special Media

Section 3.3 of the Executive order permits, by notification to the Director of ISOO, a delay in automatic declassification for up to five years for classified information contained in microfilms, motion pictures, audiotapes, videotapes, or comparable media that make a review for possible declassification exemptions more difficult or costly.

Referrals

Section 3.3 of the Executive order permits, by notification to the Director of ISOO, a delay in automatic declassification for up to three years for classified records that have been referred or transferred to an agency by another agency less than three years before automatic declassification would otherwise be required. The ISOO has interpreted this delay in its proposed new implementing directive concerning referrals (Referral Standard) to delay the automatic declassification of referred or transferred documents that are 25 years or older on December 31, 2006 to December 31, 2009. For special media, the proposed delay is until December 31, 2016.

Restricted Data and Formerly Restricted Data

Section 6.2, *General Provisions*, states that the Executive order does not supercede any requirement made by or under the Atomic Energy Act of 1954, as amended, or the National Security Act of 1947, as amended, and that RD and FRD is to be handled, protected, classified, downgraded and declassified in conformity with the provisions of the Atomic Energy Act of 1954, as amended, and regulations issued under that Act.

2. Public Law 104-106, *National Defense Authorization Act for Fiscal Year 1996*

Public Law 104-106, Section 3155, *Review of Certain Documents Before Declassification and Release*, states the Secretary of Energy shall ensure that, before a document of the Department of Energy that contains NSI is released or declassified, such document is reviewed to determine whether it contains RD, and that the Secretary may not implement the automatic declassification provisions of E. O. 12958 if the Secretary determines that such implementation could result in the automatic declassification and release of documents containing RD.

Part C

Description of Declassification Program

1. Inventory of Responsive Records

The DOE examined record management data to identify record collections that may be 25 years old and permanent, and subsequently verified the records to be responsive to the Executive order through survey sampling.

The responsive records are located in DOE Headquarters in Germantown, Maryland, and Washington, D.C.; in the National Archives and Records Administration (NARA), Washington National Records Center, Suitland, Maryland; and in the NARA Archives II facility, College Park, Maryland

To date approximately 12.7 million pages have been confirmed to be 25 years old and permanent in character. This is a 500,000 page reduction from the previously reported 13.2 million pages. This reduction is caused by the discovery that some records were previously destroyed, were temporary records, were duplicate records, or are otherwise not subject to the automatic declassification provision of the Executive order. The DOE is continuing to try to identify any remaining records that are 25 years old and permanent in character.

2. Description of Review Process

The DOE applied E.O. 12958's list of specific NSI that an agency head may exempt from automatic declassification to identify specific DOE NSI that should be exempted. DOE published the *Historical Records Declassification Guide*, current version: CG-HR-3, to identify the specific DOE NSI that is exempted. The DOE submitted CG-HR-3 to the ISOO on August 24, 2005, for forwarding to the ISCAP for approval.

The DOE acquired the services of contractor reviewers and trained them to recognize DOE NSI, RD, FRD, and UCNI, and to recognize classified information of other Government agencies.

DOE contractor reviewers examine DOE records page-by-page and apply the *Historical Records Declassification Guide* in making a determination whether the documents are declassified, exempted, or referred to another Government department/agency. Documents that are declassified, exempted, or referred are marked and tabbed accordingly. Additionally, reviewers identify documents containing RD and FRD and tab the documents for exclusion. DOE Federal staff members conduct quality control sampling of the contractor work product. Both the contractor reviewers and the DOE Federal staff members have DOE derivative declassification authority.

The DOE informs other Government departments/agencies of records suspected of containing their classified information, and maintains a database of the record collection review completion status and review results (e.g., pages declassified, excluded, exempted, or referred to other departments/agencies).

3. Declassification Authorities

DOE Employees and Contractor Personnel

Authority to derivatively declassify NSI documents based on DOE classification guidance is granted to DOE federal employees and contractor personnel after completion of approved training and testing. Federal employees and contractor personnel are granted authority for three year periods. DOE has 39 federal employees and 102 contractor personnel who can derivatively declassify NSI documents. Additionally, the National Nuclear Security Administration of the DOE has 17 federal employees and 60 contractor personnel who can derivatively declassify NSI documents.

Other Agency Employees

Code of Federal Regulations, 10 CFR Part 1045, section 1045.32, restricts that "Only designated individuals of the DOE may declassify documents containing RD." Since the NSI documents being declassified under E.O. 12958 have the potential to contain RD, DOE will not delegate declassification authority to other Government departments/ agencies. Documents marked or suspected of containing DOE classification equities are to be referred to the DOE. The DOE has established a vigorous training program to help other Government agency employees to recognize DOE equities in their collections.

4. Declassification Guides

DOE has a declassification guide, *Historical Records Declassification Guide*, that is used by DOE staff reviewing documents responsive to section 3.3 of the Executive order to identify documents that should be exempted from automatic declassification.

The guide was originally published in 1995 as CG-HR-1, and was revised in 1997 as CG-HR-2. The guide has been further revised and updated in 2005 as CG-HR-3. CG-HR-3 has been submitted to the ISOO for forwarding to the ISCAP for approval.

5. File Series Exemptions

DOE has not requested exemption for any file series at this time.

6. Interagency Cooperative Efforts

NARA Referral Resolution Center Pilot Program and Interagency Referral Center

The DOE was a participant in the NARA Referral Resolution Center Pilot Program and currently participates in its successor, the Interagency Referral Center (IRC) at NARA. Documents identified by other agencies as possibly containing DOE NSI, RD and FRD are sent to the IRC. DOE personnel review these documents to resolve any classification issues. Once reviews of referred documents are completed, the documents are referred to other agencies, if necessary, or the originating agency is notified that the review is complete and all classification issues have been resolved.

DOE has identified resources through December 31, 2009, to resolve the estimated 5 million pages of documents referred to the DOE for resolution.

Working Relationships with Other Government Agencies

The DOE has developed working relationships with other Government agencies to resolve the classification of documents referred to DOE. As these agencies identify records that may contain DOE NSI, RD, or FRD, and request resolution, the DOE resolves the classification of the documents at the other agencies' facilities. For example, in 2003 the DOE resolved the classification of 13,000 pages of Army documents at the Army Declassification Facility.

External Referral Working Group Member

DOE is a participant in the External Referral Working Group (ERWG). The goal of the ERWG is to develop a Government-wide process to resolve the classification of documents referred to other agencies.

Declassification Program Costs

1. Total Cost Estimate of Declassification Program

DOE expended approximately \$ 32 M from October 14, 1995, to September 30, 2005, to review DOE documents responsive to the Executive order. From October 1, 2005 through December 31, 2006, the DOE may expend an additional approximately \$ 3M to review the remaining DOE documents responsive to the Executive order. The DOE may expend an additional \$ 5M to \$ 10M to resolve other agency documents that are referred to the DOE depending upon the complexity and actual volume of records referred.

2. Cost Estimates by Fiscal Year

The cost to implement DOE's plan for FYs 2005 through 2007 is summarized in the following table.

Note 1: The DOE is currently budgeted to resolve during the period of January 1, 2006 through December 31, 2009, the estimated 5 million pages of documents referred to the DOE from other Government agencies. If the forthcoming ISOO referral standard and IRC record processing schedule extends the period of time to resolve the referrals, the resources for FY 2007 will be reduced.

Note 2: \$ 12,000 is the estimated cost to store 6 million pages of 25-year-old permanent NSI records at WNRC.

3. Strategy for Addressing Funding or Resource Shortfalls

There are currently no funding or resource shortfalls to complete the records by December 31, 2006, that are confirmed to be 25 years old and permanent in character.

1. Training

The DOE has an extensive training program for its own document reviewers and for other Government department/agency document reviewers.

The DOE has a multitiered document reviewer qualification program that requires extensive formal training and mentoring. Entry level reviewers undergo an 8 to 16-week formal course to recognize DOE NSI, RD, FRD, and UCNI. This course includes lectures and examinations on nuclear physics, nuclear weapon design, nuclear material production, and the classification equities of other Government agencies. Graduates of the course are able to declassify 25-year-old permanent documents that contain only DOE NSI and to upgrade protection of improperly marked documents containing RD, FRD, or UCNI.

Quality control of the entry-level reviewers is performed by document reviewers with significant education and experience in nuclear weapon related technologies and have undergone a 1-year training and mentoring program that covers the broad range of technical subjects related to the Nation's nuclear program. Graduates of this program are authorized to declassify any DOE NSI document (not just those 25 years old and permanent) and declassify/decontrol documents marked as containing RD, FRD, or UCNI. A two-person review is required to declassify a DOE NSI document less than 25 years old and to declassify/decontrol a document marked to contain RD, FRD, or UCNI.

All DOE reviewers participate in a continuing education program of technical seminars and are retested and recertified every three years to ensure technical proficiency.

To train DOE reviewers to recognize the classified information of other Government departments/agencies, DOE participates in multiagency workshops and seminars in classification equity recognition. These forums are facilitated by the ERWG.

To train other Government department/agency reviewer personnel to recognize DOE classification equities, DOE conducts a ½-day seminar and a 4-day training course in the recognition of DOE classification equities, primarily RD and FRD information. Graduates of the 4-day course are certified by DOE as Historical Records Restricted Data Reviewers. Over 2,400 individuals have completed the ½-day seminar or the 4-day course. Additionally, DOE is providing refresher sessions. Over 300 individuals have completed refresher sessions.

2. Integral File Block Concept

DOE record collections found to be responsive to the Executive order have not included documents that will be less than 25 years old on December 31, 2006. However, if record collections are found with documents less than 25 years old, the collections will be examined for possible subdivision to reduce the number of documents that would be delayed in declassification until the youngest document in the collection becomes 25 years old.

3. Rereview of Records

The DOE does not plan to rereview its records. The DOE has conducted its document reviews page-by-page with document reviewers trained to recognize DOE classified and controlled information and to recognize the classification equities of other Government departments/agencies.

Part F

External Factors That May Effect Ability to Meet December 31, 2006, Deadline

1. Budget Reductions

DOE does not expect a reduction in its authorized budget for classification/declassification activities. However, if a reduction occurs it may affect DOE's ability to declassify, exclude, exempt, or refer documents by December 31, 2006.

2. Increase in Other Classification/Declassification Activities

Increase in litigation activity, Freedom of Information Act requests, mandatory review requests, and/or security investigations requiring the DOE to review an increased number of documents for classification/declassification will draw resources from the Executive order effort and may affect DOE's ability to declassify, exclude, exempt, or refer documents by December 31, 2006.

3. Loss of Staff

DOE document reviews are primarily conducted by contractor personnel. If there is a significant loss of contractor review staff, the DOE's ability to meet the requirements of the Executive order would be adversely affected.

The total number of pages that have been and are projected to be reviewed, excluded, exempted, declassified, and/or referred are presented in the attached tables. The following notes apply to the tables:

Note 1: The quantity of DOE textual records that will be reviewed by December 31, 2006, is based on records management inventory of 25-year-old permanent classified records. To date, 12.7 million pages have been confirmed to be 25 years old and permanent in character. This is a 500,000 page reduction from the previously reported 13.2 million pages. This reduction is caused by the discovery that some records were previously destroyed, were temporary records, were duplicate records, or are otherwise not subject to the automatic declassification provision of the Executive order. The DOE is continuing to try to identify any remaining records that are 25 years old and permanent in character. It is expected that in FY 2007 and in each subsequent fiscal year, approximately 135,000 pages per year will become 25-year-old permanent classified records.

Note 2: The quantity of DOE textual records that will be exempted, excluded, declassified, or referred is an estimate based on the actual number of pages from records for FYs 2001-2005 extrapolated as needed to other years.

Note 3: The quantity of DOE textual records that will be referred to other agencies is based on the number of pages of records referred to date extrapolated for the total number of pages that will be reviewed.

Note 4: The estimate of 5 million pages of textual records that are expected to be referred to the DOE for declassification or exemption from October 1, 1995 to December 31, 2006 is based on an ERWG Survey Report of October 9, 2003. For FY 2007 and FY 2008, it is estimated that 150,000 pages each year will be referred to DOE based on 5 million pages being referred to the DOE from records originating from about 1945 to 1981.

Note 5: DOE has located a small amount of special media (approximately 6 cuft of photograph negatives) in its records that are responsive to automatic declassification. DOE has not been informed by other agencies that there are special media in their records that may contain DOE NSI, RD, FRD, or UCNI. However, DOE continues to work closely with NARA and other Government agencies to identify special media that will require review.

Note 6: The quantity of textual records reviewed from FY 1995 – FY 2004 was previously reported as 9.3 million pages. This quantity has been reduced to 8.6 million pages because one collection requires further examination. The collection will be completed by December 31, 2006.

Note 7: The DOE intends to resolve each year, from FY 2007 to FY 2009, approximately 1.7 million pages of documents referred from other Government agencies.
