
Dear Mr. Chairman:

Section 584 of the Foreign Operations, Export Financing, and Related Programs Appropriations Act, FY 2006 (P.L. 109-102), as carried forward for FY 2007 under the Revised Continuing Appropriations Resolution, 2007 (P.L. 110-5), section 678 of the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2008 (Div. J, P.L. 110-161) (SFOAA), and section 7010 of the FY 2009 SFOAA (Div. H, P.L. 111-8) require the Secretary of State to submit a report on a quarterly basis to the Committees on Appropriations that provides information on the uses of FY 2006, FY 2007, FY 2008, and FY 2009 Foreign Military Financing (FMF), International Military Education and Training, and Peacekeeping Operations funds, including a description of the obligation and expenditure of these funds, the specific country in receipt of assistance, and the use or purpose of the assistance provided.

The enclosed report lists the funds obligated and expended as of June 30, 2009 for each country, and provides a brief description of the use/purpose of the funds. Due to the volume of activity and cash flow financing for the FMF programs in Egypt and Israel, a separate section covering those two countries is included.
