ORDER

Defendant James Hitselberger will observe these additional conditions of release.

- 1) Mr. Hitselberger will participate in the High Intensity Supervision Program ("HISP") with global positioning system ("GPS") monitoring under the supervision of the District of Columbia Pretrial Services Agency ("PSA").
- 2) Mr. Hitselberger is being released into the Home Confinement Phase of the program.

 He is to reside with his aunt, Dorothy Funkhouser.
 - a) Mr. Hitselberger may leave his aunt's house only after receiving authorization from PSA for verified appointments with his defense lawyers, doctors, or pretrial services officer as needed, or to attend religious services.
 - b) Even when Mr. Hitselberger leaves his aunt's house for the limited purposes set forth above, he is expressly prohibited, as a condition of supervision, from entering or being in the immediate vicinity of Union Station, any other bus or train station that provides service outside of the Washington metropolitan area, or any airport—including (but not limited to) Washington Reagan National Airport, Washington Dulles International Airport and Baltimore-Washington International Airport—without specific

permission from this court.

- c) Mr. Hitselberger is expressly prohibited, as a condition of supervision, from traveling further than twenty-five miles from Washington, DC for any purpose.
- 3) Mr. Hitselberger will meet with his pretrial services officer once a week, and call that officer from his aunt's telephone at a designated time on every business day.
- 4) Mr. Hitselberger agrees not to seek to obtain any new passport during the pendency of this matter and to surrender any additional passports he has not already surrendered, whether current or expired.
- 5) Mr. Hitselberger will wear a GPS ankle bracelet at all times to enable appropriate monitoring by HISP and will not tamper with or remove it for any reason without authorization.
- 6) Mr. Hitselberger will keep the GPS equipment properly charged and maintain it in accordance with the directions that he will be given.
- 7) PSA shall arrange for its location monitoring vendor to directly notify both Special Agent Grant Cauthen and Special Agent Marin Lawson immediately upon receipt of an infraction or possible infraction, whenever it may occur.
- 8) If PSA is alerted or notified during business hours of any infraction or possible infraction by Mr. Hitselberger, a representative of PSA shall immediately call the chambers of the undersigned and shall immediately coordinate with Special Agents Cauthen and Lawson.
